Step by Step Guide to Classifieds

- 1. Click on 'Buy and Sell' or 'Classifieds' links
- 2. To view classifieds simply select your criteria and select 'View Classifieds'
- 3. To submit a classified, click on 'Submit a classified' in the blue menu bar
- 4. For first time sellers, choose 'Register Now'
- 5. Complete your details, taking a note of your email address used and password chosen for next time log-in
- 6. Click on 'Submit Registration' at the bottom of the page (scroll down)
- 7. Proceed to Submit a Classified
- 8. The next time you log on, simply use your email and password
- 9. Choose from the drop down lists and add your title, your closest town
- 10. You can edit your contact details for this classified submission only by typing in the boxes the preferred contact name and details
- 11. Click on 'Next' to add images
- 12. Upload images from your computer or device, ensuring they are image files (jpg or gif)
- 13. You can continue to upload up to 6 images, and select the preferred one as the lead image
- 14. If you do not have an image simply leave the image upload blank
- 15. Once happy with your submission click on 'Save Changes and Confirm'
- 16. When your ad comes up, check it and proceed to payment with **pay**mate[™]
- 17. Your classified will go live within two working days maximum once it has been approved as paid through the **pay**mate[™] portal.



General Advertising Terms of Trade

Advertising rates do not include the creation of artwork for advertisements booked by clients

The publisher reserves the right to cancel or omit any advertisement which is deemed unsuitable for publication

Advertisements must not be in breach of any clause of the Commerce Act.

Cancellation after 'go live' date must be in writing or by email and does not automatically give the advertiser the right to a refund of advertising charges.

Display advertising will be posted 'as supplied'. The onus is on the advertiser to supply correct material and copy. Change outs of artwork within the period of the advertising contract may incur an additional upload charge at the discretion of the publisher

Position requests within the specified page will be on a 'first come' basis and are not guaranteed unless agreed in writing between the parties.

Payment terms for invoiced advertising are 20th of month following invoice date (New Zealand Clients only). Classifieds and overseas advertisers should use the **pay**mate[™] service at time of posting your advertisement. Advertising remains in force unless any of the above conditions preclude this, for a period of twelve (12) months from on-line publication date (for annual contracts).

Payment on invoice is expected to be in full and any disputes arising should be lodged in writing within one month of on-line publication.

In the case of an advertiser defaulting on payment of an invoice, the publisher reserves the right to use all legal channels to obtain payment, with the costs to do so borne by the advertiser.
